Surgical mesh implanted to strengthen muscles near a hernia. Certain models have a tendency to fail at high rates and require revision surgeries.

Hip Replacements

Inferior Vena Cava Filter

Blood clot filters placed in the vein leading to the heart - shown to migrate or fracture and can puncture parts of the vein or internal organs.

Prescription baby formula for children with milk and other food allergies linked to serious bone disorders and

Paraquat

Dangerous herbicide used widely in commercial farming. Individuals exposed have significant risk of developing Parkinson's Disease.

Catheter used to remove blood clots in the brain. Recalled by FDA due to risk of unexpected death or serious injury after reports of fracturing during procedure.

Popular weedkiller linked to cancer. Bayer has agreed to settle thousands of claims and proposed a settlement fund for future claims.

Stevens-Johnson Syndrome

Potentially fatal skin disorder in which the skin blisters and the top layer of skin sheds. Can be caused by misdosing of medication.

Qualifying Injuries

Stockert 3T Heater-Cooler

Device used in open-heart surgeries to regulate a patient's body temperature. Contaminated devices have been linked to a deadly bacterial infection.

Talcum Powder/Baby Powder

Talc-based powder used for many purposes. Removed from US and Canadian markets by Johnson & Johnson amid safety concerns.

Valsartan

Blood pressure medications contaminated with carcinogens and linked to cancers. Many lots have been recalled by the FDA.

Zantac



Popular heartburn medical recalled by the FDA due to contamination with the probable human carcinogen NDMA. Linked to cancer.
