Medtronic Infuse BMP:

Used in spinal fusion surgeries linked to unwanted bone growth, inflammatory reaction, severe arm and leg pain, and possibly cancer.



Medtronic Paradigm Pump:

Insulin pump - linked to defects resulting in over or under delivery of insulin. serious illness, and/or death.



Tylenol/Acetaminophen:

Over-the-counter or prescription pain reliever linked to liver damage and liver failure.



Talcum Powder/Baby Powder:

Talc-based powder used for many purposes - linked to ovarian cancer when used for female hygiene in genital area.



GranuFlo/NaturaLyte:

Dialysate solutions - linked to metabolic alkalosis, cardiopulmonary arrest, sudden cardiac death, and other cardiac-related events.



Benicar:

Blood pressure medication - linked to severe intestinal problems that cause chronic diarrhea. dehydration, and weight loss.



Yaz/Yasmin/Ocella; NuvaRing:

Female contraceptives - linked to dangerous blood clots (i.e. deep vein thrombosis/DVT, pulmonary embolism, stroke).



Metal-on-Metal Hips:

Linked to implant loosening, pain, high metal levels in blood and need for revision surgery.



Models include DePuy ASR, Zimmer Durom Cup, DePuy Pinnacle, and others.

Stryker Rejuvenate/ABG II Hip Stem:

Modular hip stems - linked to corrosion at stem/neck juncture leading to elevated metal levels in bloodstream, necrosis, and revision surgery.




Actos:

A blood sugar control medication for type II diabetics - linked to bladder cancer.



Propecia/Proscar:

(finasteride) a hair loss and BPH drug - linked to severe and persistent sexual dysfunction men and is also linked to prostate cancer.

Drowsy Driving: An Avoidable Tragedy

On a warm September day in 2013, Jerad went to work at his construction job feeling ill and on little sleep. He took cold medication at work and finished out a long shift. Just after 5:30 PM, Jerad made a very bad choice: he decided to drive when he was drowsy. He wearily got into his pickup truck and began his familiar drive home. He began traveling down a paved county road at 55 miles per hour. Up ahead was a stop sign.

Nineteen-year-old Hannah was riding in the passenger seat as she and her boyfriend drove home on a two-lane county highway just north of the Twin Cities. Suddenly, from their right, Jerad's pickup truck



went through the stop sign and smashed into Hannah's passenger side door – T-boning the car. The force of the impact was so powerful that Hannah's seatbelt was severed. Hannah was thrown from the vehicle into a nearby ditch and was declared dead at the scene.

GoldenbergLaw was retained by Hannah's mother to investigate this tragedy. Hannah's mother and sister needed answers. Our investigation found that Jerad had fallen asleep at the wheel and he claimed to have no recollection of

the accident or the minutes leading up to it. The last checkpoint he remembered was a few miles before the scene of the accident. There was no evidence of alcohol use or foul play; Jerad had simply made the indefensible decision to get behind the wheel in a fatigued condition.

Unfortunately Minnesota does not have a law criminalizing fatigued driving. Even though studies show a fatigued driver's reaction times and cognitive abilities are similar to an intoxicated driver, such laws are difficult to enforce without a scientific method of measuring drowsiness.

After an extensive investigation and many depositions, we were able to reach a settlement for Hannah's family. In addition, the intersection where the accident occurred now has rumble strips at the stop sign and a flashing light to warn distracted or fatigued drivers that a stop is approaching.

According to the National Highway Traffic Safety Administration, drowsy driving is implicated in 100,000 crashes per year, injuring 71,000 people and killing 1,500. Yet only New Jersey has a law punishing drowsy driving beyond a misdemeanor.

A standout swimmer in high school, a thoughtful sister, and a beloved daughter, Hannah was a freshman at a local community college with dreams of becoming a radiologic technologist. She was a special young woman. We urge all of our readers to honor Hannah's memory by not driving fatigued.

DISTRACTED DRIVING FACT SHEET

Distracted driving kills over 3,000 people every year in the United States. The vast majority of these accidents can be avoided if drivers devote their undivided attention to the road. The facts are black and white: There is no exuse for driving distracted.



5 SECONDS

The average time eyes are off the road to send a text is five seconds. At 55 MPH, you can travel the length of a football field in that time. At 65 MPH, you can travel that distance in *three seconds*.

"INTEXTICATED" DRIVING

Text messaging creates a crash risk **23 times** greater than driving free of distraction. By comparison a driver with a BAC of .15, nearly twice the legal limit, has 12 times the risk of crashing as a sober driver.





9 PERCENT

Injuries resulting from distracted driving accidents surged from 387,000 in 2011 to 421,000 in 2012, an alarming increase of nine percent. Even with greater awareness, the problem is getting worse.



RISK of accident increases three times when engaging in visual-manual subtasks (reaching for a phone, dialing, reading a text) associated with handheld phones or portable devices.





1 in 6 Drivers is "High Risk"

A recent study found that nearly 16 percent of Minnesota drivers had engaged in multiple risky behaviors while driving. Risky behaviors included consuming two or more alcholic beverages before driving, texting while driving, and driving more than 10 MPH over the speed limit.







FDA WARNING: The FDA ordered a label change in 2013 after studies found Benicar use can deteriorate the intestinal villi that help digest and retain nutrients. This can lead to a condition called sprue-like enteropathy - a potentially fatal intestinal disorder that often requires hospitalization.

BENICAR-RELATED

INJURIES: Spruelike enteropathy attacks the intestinal villi and damages the ability of the small intestine to absorb nutrients. This causes food and liquid to pass too swiftly





thorough the colon without being broken down for nourishment. It is often misdiagnosed. Symptoms of sprue-like enteropathy include severe, chronic diarrhea, excessive dehydration, malnutrition, and substantial weight loss. FDA studies found that discontinuation of Benicar use resulted in improvement of these symptoms in all observed cases.
