

Mass Tort Settlements

Mass tort settlements are very different from individual cases. They are more complex and much more difficult to accomplish quickly. While each client will be made an individual settlement offer, the cases are often resolved in one large master settlement agreement (MSA) where clients may choose to opt in or out.

Often, a special independent administrator helps to then provide a specific settlement offer to a client. Once accepted, all outstanding liens must be resolved before the funds can be fully distributed.

Medtronic Infuse BMP:

Used in spinal fusion surgeries - linked to unwanted bone growth, inflammatory reaction, severe arm and leg pain and possibly cancer.



Medtronic Paradigm Pump:

Insulin pump - linked to defects resulting in over- or under- delivery of insulin, serious illness, and/or death.



Topamax:

An anti-seizure medication - linked to birth defects such as cleft palate and cleft lip.



Mirena IUD:

Contraceptive that can cause abscesses, pelvic inflammatory disease, embedment in or perforation of uterus, erosion of adjacent areas, and other related problems.



GranuFlo/Naturalyte:

Dialysate solutions - linked to metabolic alkalosis, cardiopulmonary arrest, sudden cardiac death, and other cardiac-related events.



Byetta/Januvia:

Diabetes medications - linked to an increased risk of pancreatitis and pancreatic cancer.



Yaz/Yasmin/Ocella; NuvaRing:

Female contraceptives - linked to dangerous blood clots (i.e. deep vein thrombosis/DVT, pulmonary embolism, stroke).



Metal-on-Metal Hips:

Linked to implant loosening, pain, high metal levels in blood and need for revision surgery. Models include DePuy ASR, Zimmer Durom Cup, DePuy Pinnacle, and others.



Stryker Rejuvenate/ABG II Hip Stem:

Modular hip stems - linked to corrosion at stem/neck juncture leading to elevated metal levels in bloodstream, necrosis and need for revision surgery.



Actos:

A blood sugar control medication for type II diabetics - linked to bladder cancer.



Propecia/Proscar:

(finasteride) a hair loss and BPH drug - linked to severe and persistent sexual dysfunction in men and is also linked to prostate cancer.



Testosterone Therapy Drugs:

Male hormone drugs - linked to increased risk of heart attack, stroke, or death.



- **\$2.2 Billion Settlement** includes anyone who has undergone a second replacement (revision) surgery more than 180 days after original surgery and *before* August 31, 2013.
- Cases outside of the criteria for settlement continue to be litigated. We continue to handle these cases.

BIOMET M2A

- **\$56 Million Settlement** - Plaintiffs who have undergone revision surgery more than 180 days after it was originally implanted are eligible for settlement.
- Other claims will be dismissed without prejudice on or before September 12, 2014, if a revision surgery does not take place by that date.

STRYKER ACCOLADE

- While there is no consolidated action for these cases, they are being litigated individually in courts around the country.
- As the science continues to develop on the failure of these devices, GoldenbergLaw is investigating proper court venues to bring these actions.

STRYKER (REJUVENATE/ABG II)

- There are currently two main consolidated actions throughout the country: Minnesota (federal MDL) and New Jersey (state court).
- There have been a handful of individual cases in New Jersey selected for settlement, but amounts are confidential at this time. We hope to see more results soon.

WRIGHT CONSERVE HIP

- Parties have agreed to put discovery on hold to begin a mediation program in an effort to move toward resolving as many cases as possible.
- The mediation process is expected to take 6-9 months. There is no guarantee mediation will be successful, yet this is a great opportunity for the parties to discuss case value in detail.

DEPUY PINNACLE


- Thousands of cases have been consolidated in the Northern District of Texas under Judge Kinkeade. A jury trial is set for September 2014.

ZIMMER DUROM CUP

- We have successfully settled a number of Zimmer Durom Cup cases.
- Some cases still remain in litigation.

We have litigated metal-on-metal hip cases for almost four years now and continue to work diligently toward a resolution for all of them. While we still have a ways to go, we are encouraged by the progress we have seen thus far.

SETTLEMENT FOR VICTIM OF DISTRACTED DRIVING



Our client, Gary, was driving on a Minnesota free-way when he was rear-ended by a 60,000 pound commercial truck. He was hit so forcefully that it caused a five-car chain collision in front of him.

The driver of the truck was in violation of multiple laws and regulations. He was driving a vehicle that was 21,400 pounds over registered weight and had severe air loss in the tires. He was cited for these violations, along with failure to use due care. In litigation, we discovered through the driver's cell phone records that he was using his phone at or near the time of collision.

Gary sustained injuries to his cervical spine which resulted in chronic neck pain, significant loss of motion, and permanent limitations. After he was treated with chiropractic care, cervical medial branch blocks, physical therapy and trigger point injections, Gary's doctor determined there was nothing more that could be done for his pain - it was permanent.

Gary underwent a functional capacities evaluation and vocational/psychological testing. Both concluded that, due to his injuries, Gary was no longer able to meet the physical demands of his job of 20 years. His injuries also prevented him from securing any other jobs that matched his skillset and pay. The job that Gary was able to obtain after his accident paid him approximately one third of what he was making at his previous job.

After a year of litigation, we have secured a settlement for Gary that takes the severity and permanency of his injuries into consideration. The settlement, which accounted for (among other things) his wage loss for the next several years, will allow him to put this unfortunate event behind him and move on with his life without the financial burdens he faced after the accident.



TESTOSTERONE THERAPY DRUGS LINKED TO DEADLY INJURIES



In February 2014, the FDA announced they would be investigating testosterone therapy drugs to reassess their safety. The announcement came within months of two separate studies that showed men who took testosterone therapy drugs were at an increased risk for stroke, heart attack and death.

The most recent study that was cited in the FDA's announcement found a two-fold increase in the risk of heart attack among men aged 65 years and older in the first 90 days of taking testosterone therapy. In men 65 years and

younger with a pre-existing history of heart disease, the risk was two- to three-fold. Data from other studies also showed an increased risk of cardiovascular adverse events.

These risks are serious and were not warned about. Prescriptions for these medications have risen in recent years, and many have been issued without blood tests confirming testosterone deficiency.

GoldenbergLaw is pursuing cases throughout the country on behalf of people injured or killed by these products.
